Welcome from the President

On behalf of the Young Fine Gael National Executive, I am delighted to welcome you to the 31st Young Fine Gael National Conference. This year's Conference will be the first YFG National Conference in the organisation's 44-year history to be held online, and I also hope that it will be the last.

The pandemic has forced all of us in YFG to adapt quickly and dynamically to remain relevant and on this front, I believe we have succeeded. Our policies and campaigns have focussed on advocating for sensible, practical solutions to issues relevant to young people. We have sought to modernise Young Fine Gael through the relaunch of our website, the expansion of our social media presence to new platforms and a larger audience and the launch of the YFG Women's Network, placing a renewed focus on the importance of greater female participation in politics.

For the first time in its history, YFG was forced to run the entirety of its recruitment campaign online as Ireland went into lockdown. Despite the challenges we faced, our branches across the country can take pride in the fact that together, we delivered YFG's first year-on-year increase in membership since 2016. Ní neart go cur le chéile.

It is in the spirit of collective unity of purpose that the YFG Steering Committee settled on the theme for this year's National Conference: Ar aghaidh le chéile. Unity begins with you. I see this idea not only as a theme for this National Conference but as a guiding principle and a rallying call for the future of our great organisation.

At the very first meeting of the National Executive in November 2019, every member of the team agreed that in anything we did or said, we would do it collectively and with unity of purpose. Along the way, it is true that at times we had our fair share of disagreements, but openly discussing, debating, and settling on a common position was always our guiding philosophy.

Likewise, this National Conference is a timely opportunity to engage in some of the most important discussions and debates in YFG's history and agree a common vision of how we approach these issues over the coming term and further into the future.

Ireland's young people have suffered an enormous degree of hurt as a result of the pandemic: the loss of our loved ones, our jobs, our relationships, our friendships and our education.

Throughout the weekend, we will hear from some of the most prominent changemakers on the island of Ireland and in Europe and share our ideas of how we can rebuild a future of opportunity for our young people. Tackling climate change,

shaping the digital future, charting the future of the island of Ireland, getting young people back to work, improving access to education and looking after our mental health are just some of the key debates that will feature over the weekend.

I hope that the 31st National Conference will allow YFG to emerge invigorated, with a vision for the future of what Ireland should look like once the pandemic is over and a unity of purpose to become the leaders of the future in making it happen.

As my term as President of Young Fine Gael concludes, I want to wish the incoming National Executive every success in the term ahead. Regardless of who is elected on 24 April, I know that the organisation is in safe and capable hands and I hope that by the time your term ends, you will have the opportunity to return YFG to some sense of the normality we knew pre-pandemic, all the while a larger, stronger, and more effective organisation.

To all our members, I hope that you enjoy this year's online National Conference and that by the time the next National Conference comes around, I will be able to see all of you again in person with a pint in hand and COVID-19 far behind us.

When I was elected as President of YFG in November 2019, it would have been impossible to fathom that as an Executive, we would, after a short few months, be required to oversee the reorientation of Young Fine Gael to working and campaigning exclusively online.

I am incredibly thankful for the perseverance and dedication that both the members of the National Executive and all our members showed to keep the flame of the organisation's policy and campaigning agenda burning bright. I am also deeply honoured that you were willing to put your faith in me as your President at the National Conference in Tullow in 2019. I hope I did not let you down.

National Executive Report

General Election 2020

The term of the 2019-2021 Young Fine Gael National Executive began with the onset of a General Election held in February 2020. As part of the General Election campaign, Young Fine Gael President, Daire Lawler, travelled around the country along with the National Youth Officer for the whole duration of the Leaders' Tour. Each day, a team of canvassers from around the country joined the Leaders' Tour to ensure that there was a constant YFG presence on the campaign trail. Additionally, members around the country held debate watch parties and the YFG Communications Committee worked to campaign for YFG and Fine Gael priorities during the General Election.

Youth Manifesto

With the 2020 General Election having been called a mere two months into our term, significant work was done on preparing our Youth Manifesto over the Christmas period. We launched the Manifesto, entitled Empower Your Future, in the Rebel County at the Oriel House in Ballincollig on Friday, 31 January 2020. Members of the National Executive held a meeting at the launch with An Taoiseach, and Party Leader, Leo Varadkar, and Tánaiste, Minister for Foreign Affairs, and Deputy Leader, Simon Coveney, to take them through some of our priorities in any future Programme for Government. Our five main priorities which we campaigned on during the GE were: (1) the introduction of ride sharing services in Ireland, (2) minimum wage equality for youth workers, (3) Bike to College scheme, (4) reducing the age of digital consent, and (5) reducing building height restrictions to allow for taller buildings.

Mental Health Matters

In May of 2020, the National Executive ran a campaign focusing on mental health with the aim of ring fencing

the 10% of the health budget for mental health services to coincide with the introduction of Sláintecare. This was advocated to protect our mental health services during the COVID-19 pandemic which would massively impact young people's mental health. The campaign also welcomed the launch of "Sharing the Vision", the updated policy for Mental Health from the Minister of State for Mental Health.

International Women's Day Campaign

International Women's Day was celebrated in Dáil Éireann in March 2020 with a panel discussion on women's participation in politics, hosted by Director of Engagement, Diversity and Inclusion, Emily Larkin and attended by Emer Higgins TD, Senator Emer Currie and Cllr. Vicki Casserly. The event coincided with a campaign highlighting the 5 C's of barriers to women's participation in politics. Following this event, the National Executive prioritised the establishment of the YFG Women's Network, an organ of the party that has since gone from strength to strength.

Programme for Government

Upon the announcement that Fine Gael, Fianna Fail, and the Green Party had agreed to enter into negotiations to form a coalition government, the Taoiseach appointed the YFG President to the Fine Gael Policy Reference Group for the Programme for Government (PfG). As part of the process of the negotiations, the Taoiseach held a virtual meeting with President and Vice President of YFG and MEP Maria Walsh on an extensive submission that YFG made to the PfG negotiations. Prior to the negotiations, YFG held a special National Assembly in April 2020 where members voted by 63.6% against the motion that FG should not enter into a coalition with Fianna Fail, and this membership view was represented by YFG's Executive Council members during the PfG process.





Pre-Budget Submission

On 31 August, we launched our Pre Budget-Submission (PBS), entitled Striving for Progress, written and developed by the Director of Policy and Policy and Campaigns Committee. This year, the policy submission was also accompanied by a two-week online campaign leading up to our meeting with the Minister for Finance, Paschal Donohoe and Budget Day itself. As part of this campaign, we focused each day on one of our 17 key recommendations, and our Director of Communications implemented a slick social media strategy, which included interviews on national media outlets. The PBS was one of the most extensive in recent years, with 99 policy proposals in seven key areas: (1) the environment and climate, (2) education, (3) employment, finance and tax, (4) government reform, (5) housing, health and mental health, (6) transport, and (7) agriculture and rural affairs. As part of our campaign, we met with Ministers Paschal Donohoe, Heather Humphreys, Simon Harris, Josepha Madigan, Martin Heydon, Damien English and TD's Richard Bruton and Jennifer Carroll MacNeill, the Chair and Deputy Chair of the Fine Gael Parliamentary Party. In addition to the PBS campaign, we incorporated the policies into our successful National Recruitment Campaign on the areas of: (1) eliminating VAT on condoms and menstrual cups, and (2) equalising the youth minimum wage. Although we were delighted to see some

measures, such as the announcement of the SUSI review, included in the Budget, we were disappointed that neither of our two very simple and pragmatic National Recruitment campaign proposals featured in the Budget.

National Transport Campaign

The National Transport Campaign was launched in July 2020 after months of hard-work on behalf of the Policy & Campaigns Subcommittee. In November we launched a formal document entitled Action Plan for Irish Public Transport – A National Public Transport Campaign. The document focused on and proposed 56 ways to improve public transport across Ireland through rail services, bus services and taxi services. It provided a range of ideas for the consideration of the government on how to tackle the key issue of public transport across the four provinces. Among the things that were proposed was the introduction of ridesharing initiatives, more frequent bus services in urban and rural areas and an improved rail network offering more affordable rail fares. The Policy & Campaigns Subcommittee presented the published document to Minister Hildegarde Naughton in December 2020. The in-depth document was well received and helped ensure YFG had clear policy ideas on our national public transport infrastructure.

Website

The Young Fine Gael website has been a manifesto pledge for many an Executive candidate for many years. In September 2020, we finally saw the unveiling of our brandnew website (www.yfg.ie) which is far more user friendly and professional in comparison to previous versions. Local and national events can be advertised well in advance; there is plenty of space for our numerous policy documents; and local and national press releases can also be advertised on this new interactive space. Let's all make sure that we keep it active and populated throughout this incoming Executive's term.



Recruitment Campaign

The continuing prevalence of COVID-19 resulted in a challenging and unprecedented recruitment campaign for the Organisation. The buzzing atmosphere of campus recruitment fairs was replaced by quirky online graphics and glossy URLs during the first ever Online College Recruitment campaign, which was launched in September. The rollout of Young Fine Gael's Pre-Budget Submission from late August created a lot of online and media traction for the organisation in the lead up to the Recruitment campaign. A campaign strategy was designed by the incredible Communications Committee and implemented around two of our sixteen key policy proposals:

- 1. To Abolish VAT on condoms and menstrual cups
- 2. To Abolish sub-rates of the National Minimum Wage

A number of syndicated statements were created by the Director of Communications and distributed to local branches and members. Interactive graphics and press releases also formed part of our efforts to gain as much media attention as possible throughout the Freshers Week timeframe across many of our third-level institutions. Given that these two key priorities have yet to receive any meaningful attention at Government level, it is strongly advised that they continue to form part of future Recruitment campaigns as youth issues. Feel free to also use the thousands of YFG branded "I would do anything for love - but I won't do VAT" condoms, which have been kept a secret until now! The Recruitment Campaign also centred around the rollout of an engaging and professional "Join YFG" Video - as well as some tongue-in-cheek graphics, which were designed to increase our presence online.

Climate Action Policy Paper

As one of the key issues being raised by young people, the Director of Policy made the development of policy on climate action one of his key priorities. To this end, he established a Climate and Environment Taskforce in the autumn with a view to developing YFG's policy proposal on the issue. A subset of the Policy and Campaigns Committee, the Taskforce was filled with members who have expertise and special interests in the area, along with some representatives of the Agricultural and Rural Affairs Committee. This Taskforce, consisting of Garry O'Sullivan, Vera O'Riordan, Conor Mulloy, Billy Maguire, Niall Curley, and Jack Fallon, launched their paper, entitled Realisable Sustainability, on 19 January 2021 with a two-week social media campaign. The Paper was broken up into the areas of climate and the environment, with specific policy proposals on each. As part of the promotion of the paper, it was launched at the 2021 Policy Think In described below.

Policy Think In

We held our Think In via Zoom on 30 January 2021 for almost four hours. It was hoped that the Think In could have been held in person at some point, however the pandemic intruded on those plans. There were three parts to the day: (1) the launch of our Climate Action Policy Paper, which was a discussion and Q&A with Richard Bruton TD, chaired by Vice President and Director of Policy Garry O'Sullivan; (2) a discussion and Q&A on the present and future of education in Ireland with Minister Josepha Madigan, chaired by Director of Recruitment Jen Chadwick; and (3) policy breakout rooms on (a) Leaving Cert 2021 and (b) third level funding. On this latter aspect, members voted by 80% to support a Hybrid System for LC 2021 and by 42% on option 2 of the Cassells Report on Third Level Funding (increased state funding with continuing student fees). The Hybrid System for LC 2021 was later adopted by the Minister for Education.



Dublin Day

Dublin Day was held on Halloween on the 31st of October 2020. The event was held online, and the day was broken up into 5 segments. The DRC wanted to introduce new and fun events to the membership, and we believe that we succeeded in doing so with Dublin Day. Another focus of the DRC this term was to have a broader range of engagement with membership and to empower others to be comfortable in leadership roles. We achieved this by having each segment of the Day being chaired by a different member of the Dublin Regional Council. The aim of this Dublin Day (as well as the approach to Dublin as a whole) was to combine serious policy-driven conversation with fun, relaxed lighthearted events, which can be seen with the segments as follows: an international event, surprise events, a session on Coping with COVID in Education, Among Us gameplay and finally, spooky hour with Shane Richardson. The international event featured a topical debate relating to the 2020 US elections between Joe Biden and Donald Trump. We invited representatives from both the Democratic and Republican parties to debate in favor of their respective candidates. The surprise event was the Dublin Bake Off where we prerecorded a video of various committee members of the DRC competing against one another in the Bake Off. As part of our session on Coping with COVID in Education, we invited Minister Josepha Madigan, and Deputies Emer Higgins TD and Jennifer Carroll MacNeill TD to speak about how the government aims to address problems young people

are facing regarding education. Spooky Hour with Shane Richardson featured a pumpkin carving competition as part of Halloween. All in all, the day was a success, with attendance being very high. The DRC will continue to strive to bring forth new and interesting events for Dublin.

Wild West Weekend

The first annual Wild West Weekend took place on Saturday 3rd April between 4pm and 6pm. The first portion of the event was the North West Hustings chaired by Minister Hildegarde Naughton. All candidates running at the upcoming YFG National Conference had the opportunity to present their ideas to North West members and answer any questions. Following the conclusion of the Hustings, the second portion of the event began with the airing of a short video showcasing the jiving and lip-syncing talents of various members of the North West Regional Council. When the Wild West Weekend takes place in person in the future, the dance floor will certainly be full of great jivers! Members then took part in a very challenging escape room that required those on the call to work together to get out of the first room. After just over an hour, the event was brought to an end as the escape room could have continued for hours! Overall, the event was a great success and we look forward to the next Wild West Weekend which will hopefully give members the chance to meet in person for a fun filled weekend!

Aran sweater aficionado Bríain has previously worked in politics and is currently pursuing a graduate degree in Medicine at UCC.








Policy and Campaigns
Committee

The policy of YFG over this term has largely thrived despite the pandemic (but I would say this). Many of this year's policy work areas are detailed at other parts of the Clár; the Youth Manifesto, the Programme for Government submission, the Pre Budget-Submission, the Climate Policy, and the Policy Think In. Here, I will give a small overview of what we hoped to achieve, how we fared, and where I think we fell short and that the next Executive could pick up on.

After the draining General Election, there was a twofold approach that I wanted us to take our policy. First, set out what I thought was an achievable policy agenda. This would be based on having detailed policy and campaign ready proposals in important issues squarely faced by young people. This translated into three main proposed work streams: (1) an extensive PBS that was ready by the end of summer, (2) a climate policy document, and (3) an education policy document. Second, actually getting member involvement in as much policy as possible given the many talented members we have.

On the first, I think we got 75% of the way there. Our PBS, drafted by the end of July and ready by mid-August, was incredibly detailed with 99 proposals, and we had a snappy and pragmatic climate and environment policy drafted by Christmas and ready by the New Year. Unfortunately, however, time came against us in developing a fully-fledged education policy, which I think was a pity. YFG has such a unique voice to articulate on this front, in challenging the snobby consensus about a college degree being a rite of passage, and offering sustainable solutions for third level funding. We did, however, a lot of work on apprenticeships (a long successful YFG campaign area) in our PBS, along with specific education breakout rooms at our Think In, but I really hope that the next Executive takes this work a step further. It is worth mentioning, however, that—thanks principally to the perseverance of Conor Mulloy—a Housing policy document was also developed by the Housing Policy Subcommittee, and it is hoped that this document will be launched at the beginning of the next Executive's terms with their consent.

On the second, I think some real progress has been made: the Policy and Campaigns Committee had a large and diverse membership, and we set up specific policy taskforces in the area of climate and housing. However, often when views and submissions were sought via email or on the National



Forum, responses never arrived. Yet often there was a plethora of passionate critical views about a particular policy ex post. It is understandable that we all live busy lives, and that it is not always possible to engage meaningfully on policy submissions, but it is easy to make sweeping comments in the brevity of grand rhetorical flourishes. Meaningful policy discussion is grubby and hard work. It is difficult to accurately represent members views if they don't engage. Granted, we could have, perhaps, engaged more with alternative channels, but my mother's refrain comes to mind: blood can't be drawn from an unwilling stone. Yet, YFG members certainly aren't staid stones, so that active voice needs to be channelled constructively.

I hope members at least felt that we never stopped trying to take us back to our roots as a serious policy organisation. I

have every faith that the incoming Executive will carry on this mantle. Thank you to all the members of the Policy and Campaigns Committee, the Climate and Environment Taskforce, and the Housing Taskforce for all your enthusiastic work behind the scenes.

Agricultural, Rural & Environmental Affairs Committee

Fine Gael has a proud history of achieving the support of farmers since our foundation in 1922 with a history stretching back to Michael Davitt & the Irish Land League. This agricultural support cannot be taken for granted. The Agricultural and Rural, had environmental affairs added to its portfolio in the last term. The committee chaired, by UCD Agricultural Science student, Shane Dolphin, consisted of ten enthusiastic young farmers, rural dwellers and environmentalists, who made it their goal to be the strongest voice possible on the topic of sustainable and profitable agricultural production for young farmers.

In September, the Committee presented their pre-budget submission to Minister of State, Martin Haydon TD, and discussed their proposals. The newly appointed MEP for the Midlands North-West, Colm Markey, who is a former President of Macra na Feirme, sits on the Agricultural and Rural Development Committee in the European Parliament and is the shadow rapporteur for agricultural methane production in Europe, met with the Committee on several occasions, where a wide range of issues were discussed, including: agri greenhouse gas emissions, the future of CAP, water quality, biodiversity and the Mercosur Trade deal. This sub-committee was active in their opposition against the Mercosur Trade deal and got recognition for this in the Irish agricultural press. The sub-committee Chairperson, Shane Dolphin, had a meeting with the former Minister for Agriculture, Michael Creed TD, on behalf of the committee, where they discussed farm succession and inheritance, agricultural diversity & innovation, the Nitrates and Water Frameworks Directive and forestry felling licences.

This rejuvenated and enthusiastic sub-committee got support and recognition from senior members of the Parliamentary party, for their role in making Fine Gael actively engage in discussing the issues facing agriculture in 2021. The work of this committee will help secure the support of young farmers for Fine Gael in future elections. The highlight of this committee's term was when they hosted



the first "Hogan Agricultural Webinar", with this year's topic being "Agriculture and the Environment - Rather than Being the Problem, Let's Be the Solution". This webinar, held over two consecutive days attracted an audience of over 150 men and women. To the delight of the committee only half of the attendees were YFG and Fine Gael members, the remainder consisted of agricultural science students,

members of Macra na Feirme, the IFA, environmentalists and interested rural dwellers, who wanted to shape our agrienvironmental policy. The two-pronged event first hosted, Chairman of the Fine Gael Parliamentary party, Richard Bruton TD (Former Minister for the Environment), Michael Creed TD (Former Minister for Agriculture) and former IFA President, Joe Healy as our panellists. The panellists for the second event were: Colm Markey MEP, Biodiversity Young Farmer of the Year - Joe Melody and Dr. Helen Sheridan (UCD Lecturer for Agricultural and Environmental Policy). The mix of politicians, farmers and academics allowed for a well-informed and balanced debate on agricultural and environmental sustainability. The information and points discussed in these meetings is being used to draft a YFG Agricultural Policy document, which will be launched

by the committee, in the coming weeks, at an event which will include Minister Martin Haydon, MEP Colm Markey and editor of the Irish Farmers Journal - Justin McCarthy. It is envisaged, by the Committee's Chairperson, Shane Dolphin, that agriculture will hold a strong voice in YFG with a proactive and progressive sub-committee that represents young farmer's interests and iterates that there is a home in Fine Gael for the agricultural community and it is our party that will represent their best interests.

Sustainability, both environmentally and financially, is the ultimate goal, as we strive to grow our agricultural production, while reducing our carbon emissions so we are farming, not harming.

Chuir siad plean gnímh a chur le chéile chun feiceáileacht na Gaeilge a mhéidiú ar na meáin shóisíalta, sna feachtais agus ag na himeachtaí éagsúla. Tá súil againn go n-oibreoidh an chéad Coiste Gaeilge eile leis an gcéad Ardchoiste eile chun an plean seo a chur i bhfeidhm. D'oibrigh an Choiste ar feachtais éagsúla, mar shampla feachtas trasphártaí chun pacaistiú dátheangach a thabhairt isteach ar thargaí tomhaltóra in Éirinn, cosúil le Ceanada agus leis an bhFionnlann. Ina theannta sin, d'oibrigh an Choiste ar rún don chomhdháil seo, ag iarraidh ar cheannaire Fhine Gael urlabhraí le freagracht don Ghaeilge, don Ghaeltacht agus do phobail an Gaeilge labhairthe, a cheapadh, toisc nach bhfuil aon ceann dena haireachtaí againn a bhaineann leis an nGaeilge.

There were eight members appointed to Coiste na Gaeilge: Luke Corkery, Jen Chadwick, Kenneth Conlon, Ellen Brophy, Joshua Ellul, Claire McHale, James Conachy and Fergal Flood. Luke Corkery was selected as chairperson of the committee. The Coiste decided to focus on promoting the Irish language within the organisation. They put together an action plan to increase the visibility of Irish on social media, in campaigns and at various events. We hope the next Coiste will work with the next National Executive to implement their plans. The Coiste worked on various campaigns, for example a cross-party campaign to introduce bilingual packaging on consumer products in Ireland, similar to Canada and Finland. As well as that, the Coiste worked on a motion for this Conference, calling on the Leader of Fine Gael to appoint a spokesperson for the Irish language, the Gaeltacht and the Irish-speaking community, because we do not hold any ministries associated with the Irish language.



Youth political wings call for implementation of national bilingual packaging policy

Labour Youth, Ógra Shinn Féin, Social Democrats' College & University Branches, Young Fine Gael, and Young Greens/Óige Ghlas along with Conradh na Gaeilge are calling on Minister for the Gaeltacht Catherine Martin and Minister of State for the Gaeltacht Jack Chambers to put in place a bilingual packaging policy by the end of 2024. This policy would ensure that throughout the State, all text on a product, its container or wrapping, or on a document or object supplied with it, including the directions for use and the warranty certificates, will be drafted in Irish. The Irish inscription may be accompanied with a translation or translations, but no inscription in another language may be given greater prominence than that in Irish. By setting Irish as the default language with an option for a translation to accompany, this allows for monolingual packaging within the Gaeltacht areas and bilingual packaging nationwide.

We regard this proposal as a pragmatic way to increase literacy rates and speaking opportunities for the Irish language without any increase in spending by the state. This policy, adopted by the state, would give greater visibility and accessibility to the Irish language for learners and native speakers and allow citizens greater flexibility to go about their lives in either Irish or English. We contend this policy to be in large part one of public education which will see gains for (but not limited to) teachers, students, those required to have knowledge of Irish for their employment such as in the civil service, and the Im+ people actively learning Irish on Duolingo, a language learning app, every week. It will also provide new opportunities of employment for Irish speakers in translation and marketing.

We contend this policy would incur no new costs to the average business that they wouldn't already incur over a short-run period i.e., in packaging, printing, and marketing costs. In the event of marginal costs, the Business Support Scheme 2021 grant is available, through Foras na Gaeilge, to small and medium-sized commercial enterprises to promote Irish in their businesses through signage, packaging, websites, and printed marketing material. In the medium and long run this policy will serve businesses interests by creating bilingual workers that are going to be flexible in the ways demanded by the 21st century. International enterprises

International Committee Report

YFG's International Committee 2020-2021, by Paula Campbell (YFG International Secretary)

Whilst YFG's International Committee has not met in a room over the course of our term, we did not let that stop us. We used the new-found acceptance of video calls to connect YFG members with our friends from the continent, meet with our MEPs, as well as conduct some invaluable research ahead of issuing our second iteration of YFG's Future of Europe policy.

YFG's Future of Europe Policy

The committee agreed early on that we would revisit YFG's Future of Europe policy - Building a Stronger Union - in light of the new challenges posed to Europe by the Covid19 pandemic. As part of our research we met with former MEP Brian Hayes, to discuss defence and finance policy, and with YEPP President Lidia Pereira MEP, to discuss economics and foreign affairs.

After a lot of work from the committee we agreed to expand upon the 2019 document while not deviating from the structured asks of before as we still believe that the key asks are for a more competitive, assertive and secure European Union. This new iteration seeks to not only take into account and offer solutions to the COVID-19 crisis, but also better respond to the challenges and opportunities presented by the rise of China and the 2020 U.S. General Election.

We met with Frances Fitzgerald MEP and Maria Walsh MEP to present our ideas and take on their feedback as well as hear updates from them on their work in the European Parliament.

We officially launched the policy with Minister Simon Coveney TD, Lidia Pereira MEP and Maria Walsh MEP in February. Minister Coveney spoke at length about our ideas for Ireland's foreign policy as well as how the EU can take a more active role in geopolitical affairs. This comes at a particularly important time for Ireland as we hold a seat on



the UN Security Council. YFG members had the opportunity to ask the Minister and the MEPs questions during a Q&A session at the end of the presentation.

Taiwan

We were pleased to meet with the Taiwan Representative to Ireland Pierre Tzu-pao Yang in October 2020 to discuss the challenges of rising authoritarianism and the threats it



poses to liberal democracies like Taiwan. After our meeting we released a statement calling on the Irish Government to follow the European Union and a number of our fellow Member States by formally establishing a representative office in Taipei.

Connecting with the Continent

YFG participated in several online YEPP Council meetings and NKSU meetings over the term. We were also pleased to support YEPP's Vaccines work campaign and their With Belarus campaign. We are looking forward to attending the next YEPP Council in April 2021 where we will be presenting a resolution on the EU's China policy in light of their persecution of Uyghurs.

In January we held an online event for members with JU Germany, focusing on the CDU leadership contest as Germany entered its super election year. We were given a run down of the candidates, the influence of the CSU on the race, what to look for in the upcoming federal state level elections and general election by Konstanze Fuchs (JU NRW) and Alexander Jackson (JU Hessen).

With a desire to continue following European elections, we held an event for members on the Dutch elections in February with CDJA, our Dutch sister party, and KDU Sweden, our Swedish sister party. As luck would have it, KDU approached CDJA at the same time as YFG with a similar interest in discussing the Dutch election. With help from Niels Honkoop

(CDJA Gouda) and Carl Olehäll (KDU Smögen) we ran the three party event with CDA candidate Huibert van Rossum leading the discussion on the cause of the snap election and the CDA campaign. The event finished up with discussions by members in breakout rooms and multiple pledges to offer a couch when it is once again safe to go city-hopping across Ireland. the Netherlands and Sweden.

Northern Ireland Dimension

Last but by no means least we were very happy to support and assist with YFG's Northern Ireland event: Future Opportunities for Northern Ireland in March 2021. Jude Perry moderated the event where our special guests were Fergus O'Dowd TD, Emma DeSouza, Neale Richmond TD, Sir Jeffrey Donaldson MP, and Matthew O'Toole MLA. The event was really well attended and sparked some interesting conversations but left everyone with a renewed sense of determination to fully utilise the institutions of the Republic, Northern Ireland and the UK as envisaged under the Good Friday Agreement, promoting peace and cooperation on our islands.

The 2020 -2021 Young Fine Gael International Committee was made up of Paula Campbell, Eoin Scarlett, Áine Cooke, Sarah Canavan, Mourad Mejdi, Luke Byrne, Art O'Mahony, Jude Perry, Drummond McGinn, Conor McArdle, Ali Khan, Jamie McCourt and Jake Kieran. Our two National Executive liaisons were Shane Price and Obi Ekoba.

Women's Network Report

YFG Women's Network Overview

The Women's Network committee had an exciting and eventful year with an array of events, campaigns and training sessions organised over the term. A committee of eleven members was set-up in May 2020 by Emily Larkin and Susan Bannigan to ensure the continuation of the Women's Network and to establish a long-term committee in addressing the lack of women in leadership roles within YFG.

The Women's Network committee held seven events across the term. We launched this term with a panel discussion including former Tánaiste and current MEP, Frances Fitzgerald, Deputy Jennifer Carroll-MacNeill and Cllr Thomasina Connell. and current Minister for Justice. Helen McEntee.

This was followed by two webinars helping members with career advice on working as a local councillor, the role of the Fine Gael Executive Council and political roles in Brussels with FPP

During the summer, we ran a campaign calling on the Minister for Education to make consent mandatory in all sexual education classes at secondary school level.

In collaboration with the Fine Gael Women's Network we organised a coffee morning fundraiser that saw over €1000 raised for Women's Aid with Minister for Justice Helen McEntee in attendance. We also did a short networking session that allowed members from both networks to connect.

We participated in a joint campaign with other youth wings to call on Minister Gorman to end period poverty in Direct Provision in Spring.

We provided a training session on running in the upcoming YFG national executive elections from previous and current members of the national exec offering advice and support to

new candidates. We then hosted a private coffee morning between all the female candidates and committee members to offer support to them in their candidacies.

Macántacht

Uaillmhian

Tá Ógra Fhine Gael ag iarraidh Éire uailleach a chruthú. Ba mhaith linn é seo a dhéanamh trí thionscnamh a dhéanamh ar iomhá do thodhchaí na hÉireann atá muiníneach sa bhaile agus thar lear. Seasimid do shaol dóchasach. Chun é seo a dhéanamh creidimid go gcaithfimid cáil idirnáisiúnta na hÉireann a chothú trí thacaíocht a thabhairt don Aontas Eorpach, agus cosaint a thabhairt do comhphobailtrí forbairt réigiúnach agus trí thodchaí ár bpáistí a choiméad trí aire a thabhairt don timpeallacht.

MOTION 1

Young Fine Gael calls on a partnership between Alliance Youth in Northern Ireland and Young Fine Gael to build greater cross-border relations on issues affecting young people on the entire island of Ireland.

MOTION 2

Calls on the Government and the HSE to undertake a Jigsaw project (Youth Mental Health Centre) in every county in Ireland.

Submitted by: Tipperary YFG, related motions from UCC YFG and Roscommon Galway YFG

MOTION 3

Young Fine Gael calls on the government to condemn the treatment of the Uighur Muslims in Xingjiang China and to recognise the policies of the CCP as a Cultural Genocide. As a recognition of this, and the violation of the Hong Kong Basic Law, YFG calls on the European Union to reject the Comprehensive Agreement on Investment with China.

Young Fine Gael calls on the government to allow foreign insurance companies to offer car insurance to increase competitiveness and decrease prices as a result.

Young Fine Gael calls on the party leader to appoint a party TD as spokesperson for the Irish Language, the Gaeltacht and the Irish speaking community.

MOTION 6

Young Fine Gael calls on the government to hold a referendum allowing for EU citizens resident and working in Ireland for at least five years the right to vote in national elections.

Young Fine Gael calls for the establishment and funding of Rural Working Hubs in tandem with the roll-out of the National Broadband Plan, to facilitate remote working in a community setting and a clear timeline for its delivery.

Constitutional Amendments for the Young Fine Gael 31st National Conference

AMENDMENT 1: PREAMBLE

(Kerry YFG)

That the Preamble be amended to insert the following after "of the Fine Gael party":

"and is proudly allied with fellow Christian Democratic and centre-right youth political organisations who are members of the Youth of the European People's Party".

Effect: Amends the Preamble to include a mention of Young Fine Gael's membership of the Youth of the European People's Party.

AMENDMENT 2: CAMPAIGNS

(UL YFG)

Delete the current sections 1.4 and 1.5 and insert a new Article 1.4 to read as follows:

"The Organisation shall actively campaign;

(a) In all referenda, where upon the position of the Organisation is determined by a vote of the membership taken at a national assembly (in person or virtually) held when the wording of the referenda question is known.

(b) In all elections where Fine Gael candidates or independent candidates endorsed by Fine Gael Executive Council appear on the ballot.

(c) On Policy positions determined by the membership or a vote of the National Executive, in line with the provisions laid out in section 9 of this constitution."

Effect: Compels the Organisation to actively campaign in circumstances where:

(a) A vote is taken by the National Assembly (the National Executive would need to call the Assembly);

(b) In all elections (Local, European, General Election, Seanad Election, Presidential) where

Independent candidates endorsed by Fine Gael Executive Council appear on the ballot; and (c) official YFG policy.

AMENDMENT 3: ANTI-DISCRIMINATION

(Kilkenny YFG)

Insert a new Article 2.11 to read as follows:

"No member shall be required to qualify for, or be disqualified from, any office within the Organisation on the basis of their sex, race, religious beliefs, or sexual orientation."

Effect: Prohibits discrimination against members on the basis of their sex, race, religious beliefs, or sexual orientation.

AMENDMENT 4: MEMBERSHIP AGE

(Dublin Bay North (Alfie Byrne) YFG, Kerry YFG, UCC YFG)

In Article 3.2. to amend "35" to "30".

Effect: Reduces the age limit for YFG membership from 35 to 30. No member may reaffiliate after their 30th birthday. All current members over the age of 30 would remain as members until the next affiliation date.

AMENDMENT 5: BRANCH CAMPAIGNS

(Galway East (Patrick Hogan) YFG, NUI Galway YFG)

Insert a new Article 4.11 to read as follows:

"A branch may run a local campaign in their area or campaign for official policy of the Organisation, provided that the campaign is not contradictory to official policy and that the relevant Regional Organiser is informed not less than seven days before any campaign commences."

Effect: Allows local branches to run local campaigns provided they do not contradict official Young Fine Gael policy.

AMENDMENT 6: NATIONAL EXECUTIVE - CASTING VOTE

(Dublin Bay North (Alfie Byrne) YFG, Galway East (Patrick Hogan) YFG, Kerry YFG, UCC YFG)

Delete Article 5.2

Effect: Deletes a provision which purports to state that the President does not have a casting vote at National Executive Meetings. As it stands, Article 5.2 is in conflict with a determination by the Fine Gael Executive Council on 18 June 2019 that the President of YFG, as Chair of the National Executive, should inherently have a casting vote at meetings of the National Executive.

AMENDMENT 7: NATIONAL EXECUTIVE – COLLECTIVE RESPONSIBILITY

(Dublin Bay North (Alfie Byrne) YFG, Galway East (Patrick Hogan) YFG, Kerry YFG, UCC YFG)

To insert the following at Article 5.2:

"The National Executive shall act collectively and speak with one voice, and its discussions shall be bound by confidentiality. The President, or in his/her absence the Vice President or the National Youth Officer, shall act as spokesperson for the National Executive and the Organisation."

Effect: Places an onus of collective responsibility on the National Executive, binds discussions of the National Executive to confidentiality and codifies the existing practice that the President, or in his/her absence the Vice President or the National Youth Officer, shall act as spokesperson for the National Executive and the Organisation.

AMENDMENT 8: NATIONAL EXECUTIVE - CO-OPTIONS

(UL YFG)

Delete Article 5.3(d) and insert a new Article 5.3(d) which reads as follows:

"Up to three additional members may be co-opted by the President, each of whom must receive the express consent of a majority of the National Executive to redress any imbalances that exist as regards region and skills."

Effect: Since 2001, the President has had the power

to co-opt a number of additional members, at his/ her personal discretion, to address regional or skills imbalances. This amendment would remove that power, and require a majority vote by the National Executive for future co-options.

AMENDMENT 9: NATIONAL EXECUTIVE - STANDING ORDERS

(Dublin Bay North (Alfie Byrne) YFG, Galway East (Patrick Hogan) YFG)

Insert a new Article 5.5 as follows:-

"The National Executive may adopt Standing Orders from time to time to govern the conduct of its meetings and its day-to-day operations."

Effect: Clarifies that the National Executive may adopt Standing Orders to govern its workings.

AMENDMENT 10: NATIONAL EXECUTIVE - TRAVEL ABROAD

(Galway East (Patrick Hogan) YFG)

Insert a new Article 5:10 to read as follows:

"Any member of the National Executive who leaves the island of Ireland for a continuous period of not less than two months duration shall be deemed to not be in a position to perform their duties and shall be deemed to have resigned their position on the National Executive."

Effect: Provides that a member of the National Executive will be deemed to have resigned their position on the National Executive if they leave the island of Ireland for more than 2 months.

AMENDMENT 11: YFG WOMEN'S NFTWORK

(YFG Women's Network, Dublin Mid-West YFG; Galway East (Patrick Hogan) YFG, Kerry YFG, NUI Galway YFG, Trinity College Dublin YFG)

Insert a new 5.19 to read as follows:



"A Women's Network Committee shall be established at the start of each Executive term in accordance with Article 5.18 of this Constitution. The President in agreement with the National Executive shall nominate a member of the National Executive to act as liaison to the Network."

Effect: Allows the President, in agreement with the National Executive, to appoint a chair, Exec Liaison and committee for the Women's Network.

AMENDMENT 12: NATIONAL EXECUTIVE - VOTING AT EXECUTIVE COUNCIL

(Dublin Bay North (Alfie Byrne) YFG, Galway East (Patrick Hogan) YFG)

Insert a new Article 5.23:

"The Organisation's three representatives on the Fine Gael Executive Council shall, as far as practicable, speak, act and vote as members of that body in line with the official positions taken by the Organisation, either by the National Executive, the National Assembly, or the National Conference, as the case may be. The National Executive shall monitor the observance of this article and receive reports from the three representatives."

Effect: Compels the Organisation's three representatives on the Fine Gael Executive Council to speak, act and vote as members of the body in line with the positions of the Organisation.

AMENDMENT 13: VOTING RIGHTS AT NATIONAL CONFERENCE - 30 DAY RULE

(YFG National Executive)

Delete Article 6.3 and insert a new Article 6.3 to reads as follows:

Every member who attained membership of the Organisation as prescribed in Article 3.1 not less than 30 days in advance of the commencement of the National Conference or at the close of college branch affiliations, whichever is later, shall be entitled to one vote at the National Conference subject to the presentation of a photo ID.

Effect: Clarifies which members of the Organisation are entitled to vote at a YFG National Conference

AMENDMENT 14: VOTING RIGHTS AT NATIONAL CONFERENCE- AFFILIATION DATE RULE

(Dublin Bay North (Alfie Byrne) YFG)

Delete Article 6.3 and replace with a new Article 6.3:

"Every member of the Organisation who attained membership as prescribed in Article 3.1 no later than 31 October preceding the National Conference shall be entitled to one vote at the National Conference subject to the presentation of photo ID."

Effect: Clarifies which members of the Organisation are entitled to vote at a YFG National Conference.

[Falls if Amendment 13 is passed.]

AMENDMENT 15: NATIONAL CONFERENCE - STEERING COMMITTEE

(Dublin Bay North (Alfie Byrne) YFG, Galway East (Patrick Hogan) YFG)

Delete article 7.1 and replace with a new Article 7.1 as follows:

"The National Conference Steering Committee shall be appointed by the National Executive and shall consist of not less than five and not more than eight persons and shall be comprised of:-

- a) The President and Vice-President (if not seeking re-election)
- b) Members of the outgoing National Executive (not seeking re-election), such that the total number of members of the National Executive shall be at least four
- c) The National Youth Officer
- d) Not less than two other members of Young Fine Gael or Fine Gael who possess particular skills or experience which would be essential to the arrangement of the logistics of the National Conference, or who are members of Fine Gael in the constituency where the National Conference is taking place.

The National Executive shall appoint a Chair of the National Conference Steering Committee, who shall not be a member of the outgoing National Executive, and issue Standing Orders to it upon its appointment which shall govern its operations."

Effect: Changes the composition of the YFG National Steering Committee and limits the size of it to between five and eight members in line with recent National Conferences.

AMENDMENT 16: NATIONAL COUNCIL

(Dublin Bay North (Alfie Byrne) YFG, Galway East (Patrick Hogan) YFG)

Delete Articles 8, 2.2(c) and 5.5

Effect: Abolishes the National Council introduced at the 30th National Conference.

AMENDMENT 17: MEDIA

(Kilkenny YFG)

Insert a new Article 9.4 to read as follows:

"Only the National Executive may issue comments or press releases to the national media on any issue relating to the Organisation or its policies. Units or Organs may not issue comments or press releases to the national media without the prior authorisation of the National Executive. Branches may engage with local media in their constituency in order to campaign on any local issues and to promote existing official national policy of the Organisation."

Effect: Clarifies that only the National Executive can comment to the national media in respect of any matter. Branches can issue press releases to the national media with the prior authorisation of the National Executive. Branches can engage with local media in relation to local issues or to promote existing YFG policy.

AMENDMENT 18: CONSTITUENCY YOUTH OFFICERS

(Kerry YFG, UCC YFG)

Add a new paragraph at the end of Article 12.2 to say as follows:

"The National Executive shall request a report from each Constituency Youth Officer on their work once in each calendar year. Any Constituency Youth Officer who fails to submit such a report within three months of it being requested shall be deemed to have vacated the position, with a replacement to be selected

in accordance with the processes outlined in this Article."

Effect: Requires Constituency Youth Officers to submit a report to the National Executive once each year. Failure to submit such a report within three months will result in the Constituency Youth Officer being deemed to have resigned their position.

AMENDMENT 19: QUORUM FOR CONSTITUTIONAL AMENDMENTS

(Dublin Bay North (Alfie Byrne) YFG, Galway East (Patrick Hogan) YFG)

Amend 13.1 to add a new sentence after "National Conference".

"For the purposes of this article, a quorum shall be one-quarter of all registered delegates of the National Conference."

Effect: Requires that a minimum quorum of onequarter of all registered delegates be present in order for an amendment to the YFG Constitution and Rules to be passed.

AMENDMENT 20: GENDER-NEUTRAL

(UL YFG)

"To amend each of Articles 2.9, 5.9, 5.14, 5.15, 5.19 and 10.4 by replacing each occurrence of the words "he", "his", and "himself" with the words "they", "their" and "themselves" respectively

And

Delete the following from Article 13.3:

"Words denoting the female gender shall include the male gender and vice versa"

Effect: Amends the Constitution to replace all references to the male gender with gender-neutral references



Standing Orders for the 31st Young Fine Gael National Conference

Part 1 – Interpretation (for the purposes of these Standing Orders):

'Amendments to the Young Fine Gael Constitution and Rules' means the amendments to the Young Fine Gael Constitution and Rules proposed by certain Units or Organs of the Organisation and detailed in the National Conference Clár.

'Conference Motions' means the policy motions proposed by certain Units or Organs of the Organisation, selected for debate by the National Conference Steering Committee and detailed in the National Conference Clár.

'Chairperson' means the individual presiding at a Session.

'Emergency Motion' means any motion other than a Conference Motion or an Amendment to the Young Fine Gael Constitution and Rules and not appearing on the National Conference Clár, as prescribed in Part 10 of these Standing Orders.

'Host Zoom Account' is the Fine Gael Zoom Account which will host each Session of the National Conference and to which persons wishing to raise a point or wishing to speak at any Session registers their desire to do so.

'Mute' means a remote action, taken by the Host and/or a member of the National Conference Steering Committee through Zoom, which deactivates the microphone of a Registered Delegate or Observer.

'National Conference' means the 31st National Conference of Young Fine Gael.

'National Conference Clár' means the programme/agenda for the National Conference.

'National Conference Steering Committee' means those individuals appointed under Article 7 of the Young

appointed under Article / of the Young Fine Gael Constitution and Rules to organise the National Conference and who have not otherwise resigned.

'National Executive' means the current Young Fine Gael National Executive.

'National Executive Elections'

means the elections of the President of Young Fine Gael, the Vice-President of Young Fine Gael and the ordinary members of the National Executive as outlined in Article 6 of the Young Fine Gael Constitution and Rules.

'Observer' means a member of Young Fine Gael who is not a Registered Delegate, or any other person in attendance at the National Conference as an invited guest.

'Quorum' means 15% of the total number of Registered Delegates.

'Registered Delegate' means a member of Young Fine Gael who has attained membership on or before the 15th March 2021, and who appears on the Register of Members, and who has registered their attendance via the National Conference Online-Registration Form before Noon on 10 April 2021, and who displays their full name and branch name on their Zoom profile/thumbnail, and who shall be capable of being heard and (where practicable) be seen by other members in attendance at Sessions of the National Conference.

'Returning Officer' means the General Secretary of Fine Gael or his nominee.

'Session' means a full online meeting of the National Conference meeting in plenary session, or apart thereof (as applicable), and as outlined in the National Conference Clár.

'Steering Committee Email Account' means yfgsteering2021@gmail.com, being the email address of the National Conference Steering Committee.

'The Great Debate' means the team debating competition being held on Friday 16th April 2021 at the 31st National Conference.

'Unit(s) and Organs of the Organisation' has the meaning prescribed under Article 2 of the Young Fine Gael National Constitution and Rules.

Young Fine Gael Constitution and Rules' refers to the constitution and rules of Young Fine Gael as adopted by the 30th National Conference of Young Fine Gael.

'Zoom' means the videoconferencing software through which the National Conference is being hosted.

Part 2 - Attendance

- All references to Registered
 Delegates being 'present'
 includes participating through
 virtual means, including
 audio conferencing or video
 conferencing at a Session that is
 hosted via the Host Account.
- 2. Registered Delegates and Observers will be admitted to all

Sessions by the Host Account subject to Part 7(b) and Part 7(c) of these Standing Orders.

Part 3 – Ultimate Determination

The ruling of the Chairperson of any Session shall be final on all matters.

Part 4 - Referral

The Chairperson may adjourn a Session in order to consult with the National Conference Steering Committee on any matter relating to the National Conference.

Part 5 – Conference Motions and Amendments to the Young Fine Gael Constitution and Rules

- Other than in the case of Emergency Motions as provided for under Part 10 below, only Conference Motions and Amendments to the Young Fine Gael Constitution and Rules which are listed in the National Conference Clár may be moved.
- 2. A Conference Motion or an Amendment to the Young Fine Gael Constitution and Rules may only be moved by the Unit or Organ of the Organisation listed on the National Conference Clár.

Part 6 - Quorum at Sessions

 Where fewer than 15% of Registered Delegates are present, a Session shall be deemed to be

- inquorate and the Chairperson shall adjourn that Session until they deem that Session to be quorate.
- 2. Any Registered Delegate may call a quorum count.
- 3. Only one quorum count may be called at each Session.

Part 7 – Speakers and Registered Delegates

- At all Sessions and at the Great Debate, speakers shall only be allowed speak for the duration as announced by the Chairperson.
- 2. Registered Delegates must display their full name and branch name on their Zoom profile/thumbnail.

 Observers must display their full name and branch name where practicable.
- Registered Delegates and Observers must ensure that their camera is switched on at all times, where possible. In the event that a participant is not in a position to switch on their camera, a recent photograph of themselves shall be displayed instead.

Part 8 - Amendments

1. Amendments to Conference
Motions may be submitted to
the Steering Committee Email
Account before 21:00 on Thursday
15th April 2021 and must be
supported by no less than two
Registered Delegates. Such
amendments may be put to the
floor at the Session subject to the

- absolute discretion of the National Conference Steering Committee.
- Emergency Motions and Amendments to the Young Fine Gael Constitution and Rules may not be further amended pursuant to this part.

Part 9 – Relevancy/Disruption

- 1. If any Registered Delegate or any other person is directed to cease speaking on the grounds of irrelevancy, disruption or being in excess of the allotted time, that Registered Delegate or person must do so forthwith.
- In any event where a Registered
 Delegate or any other person
 refuses to cease speaking in line
 with subsection (a) of this Part, the
 Host or a member of the National
 Conference Steering Committee
 may mute that Registered
 Delegate.

Part 10 - Emergency Motions

- Emergency Motions may be submitted to the Host Account and National Conference Steering Committee Email Account and may be put to the floor at a Session subject to their absolute discretion.
- 2. An Emergency Motion must be submitted to the National Conference Steering Committee Email Account before 09:00 on Saturday 17th April 2021 and must be supported by no less than eight Registered Delegates.



- 3. Emergency Motions must only deal with events of exceptional significance.
- 4. All decisions of the National Conference Steering Committee in respect of this Part shall be final.

Part 11 - Voting

1. SESSIONS

- 1. The Chairperson of a Session shall appoint tellers for the duration of that Session.
- When a vote is called, the tellers shall ensure that only Registered Delegates are admitted to the Session.
- 2. Registered Delegates who do not comply with Part 7(c) of these Standing Orders will not be permitted to vote in any Session.
- All voting at all Sessions shall take place via a multiple choice online Zoom poll.
- 4. The multiple choice options for each online Zoom poll shall be as follows:
 - In Favour
 - Against
 - Abstain
- 5. Conference Motions (or any amendments thereto), Emergency Motions and Amendments to the Young Fine Gael Constitution and Rules shall be put to a vote when, in the view of the Chairperson, they have been fully discussed.
- 6. In the event that an amendment to a Conference Motion is

- proposed, the following procedure shall apply:
- The Session must first vote on accepting the amendment.
- If the amendment is passed, the Conference Motion as amended shall be put to the Session.
- In the event that there is more than one amendment proposed the Chairperson shall call for a vote on the amendments, which in his opinion are the most farreaching first.
- 7. A Conference Motion (or any amendment thereto) will be deemed to have been carried when a simple majority of Registered Delegates present at the Session vote in favour of the motion.
- 8. Amendments to the Young Fine Gael Constitution and Rules will be deemed to have been carried when they achieve a two-thirds majority of Registered Delegates present at a quorate Session, in accordance with Article 13.1 of the Young Fine Gael Constitution and Rules.
- 9. After voting, the total number of votes in Favour, Against and Abstentions shall be announced at the Session.
- The Chairperson may order a re-vote when not less than two Registered Delegates request a re-vote.
- 11. In the event of a tie, a Conference Motion (or any amendments

- thereto) or Emergency Motion shall be deemed not to have been carried, as a majority has not been attained.
- 12. Once a re-vote has been called and ruled by the Chairperson, and a result declared, no further requests for re-votes shall be considered.

2. VOTING AT NATIONAL EXECUTIVE ELECTIONS

- All members of Young Fine Gael who attained membership on or before 15 March 2021 are entitled to vote at the National Executive Elections irrespective of whether they are Registered Delegates.
- 2. The National Executive Elections shall be conducted in accordance with the procedures adopted by the National Executive, approved by the Fine Gael Executive Council, and as outlined to members by the National Conference Steering Committee.
- 3. These procedures, and the counting of votes in the National Executive Elections, shall be overseen at all times by the Returning Officer.

Part 12 - Standing Orders

Once these Standing Orders have been accepted by the National Conference, they shall not be suspended or amended.
