1.0 Missions

1- All public transport to be carbon neutral in 2035.

Making all public transport carbon neutral by 2035 is an ambitious but necessary goal to mitigate the impacts of climate change. This would require a significant shift towards the use of electric and renewable energy sources, as well as the implementation of other low-carbon transportation technologies. Achieving this goal would have significant benefits for the environment, improving air quality, and reducing greenhouse gas emissions. Additionally, it would create jobs in the renewable energy and transportation sectors, contributing to economic growth and sustainability. However, achieving this goal would require significant investment in infrastructure and policy support, as well as broad public engagement and participation.

2- Reduce vehicle emissions in city centres by half.

Reducing vehicle emissions in city centres by half is an important step towards improving air quality, public health, and mitigating the impacts of climate change. This can be achieved through the promotion of low-emission vehicles, such as electric and hybrid cars, and the adoption of cleaner fuels such as biofuels and hydrogen. Additionally, it can be achieved through the promotion of alternative modes of transportation such as walking, cycling, and public transport, reducing the number of cars on the road. By reducing vehicle emissions, the city can create a healthier and more pleasant environment for its residents and visitors, while also contributing to the global transition to a low-carbon economy.

3 - Implement a comprehensive transportation strategy to reduce dependence on individual transportation by 40%, aiming for an average of one and a half cars per household.

Through measures such as promoting alternative modes of transportation, improving public transportation infrastructure, expanding cycling and pedestrian-friendly infrastructure, implementing car-sharing programs, providing incentives for carpooling, and raising public awareness about the benefits of sustainable transportation.

4 - Aim to have bus or tram stops within an average of 1 km away from households in urban areas.

Aiming to have bus or tram stops within an average 1km distance from households in urban areas seeks to improve accessibility to public transport, promote sustainable mobility, and enhance quality of life. By bringing transportation options closer to residents, this initiative encourages the use of public transport, reduces reliance on private vehicles, and contributes to lower carbon emissions and less traffic congestion. Ultimately, this goal fosters more connected, greener, and more livable urban environments.

5- Aim to improve intermodal connectivity

Intermodal connectivity is a vital mission that aims to seamlessly integrate different modes of transportation, creating efficient and convenient travel experiences.



By connecting various transportation networks, including roads, railways, airports, and seaports, this mission facilitates smooth and hassle-free transfers for both passengers and cargo. It involves developing integrated transportation hubs, improving infrastructure, and implementing intelligent systems to optimize the flow of transportation. Additionally, the mission could focus on enhancing last-mile connectivity through initiatives like bike-sharing programs, pedestrian-friendly infrastructure, and improved public transportation networks.

2.0 Policies

2.1 Infrastructure

1 - YFG calls for the development of express rail connecting Belfast, Dublin Limerick Cork Galway and Waterford.

The development of an express rail network connecting Belfast, Dublin, Limerick, Cork, Galway, and Waterford aims to enhance regional connectivity, promote economic growth, and reduce travel times. This modern and efficient transportation system will encourage the use of public transport, reducing traffic congestion and lowering carbon emissions. By linking major cities, the express rail will foster greater collaboration, tourism, and regional development throughout Ireland.

2 - YFG calls for the redevelopment of the A1 and A5 national roads.

The redevelopment of the A1 and A5 national roads in Northern Ireland aims to enhance connectivity, improve road safety, and support economic growth in the region. By upgrading these key transport corridors, travel times will be reduced, and accessibility to vital services and business opportunities will be improved. This infrastructure investment not only promotes regional development but also contributes to a more efficient and sustainable transportation network for the entire island.

3 - YFG calls for the redevelopment of the M50.

The redevelopment of the M50 motorway in Ireland aims to improve traffic flow, enhance safety, and reduce congestion on this critical transport artery. By upgrading infrastructure, expanding capacity, and implementing intelligent transport systems, the project promotes more efficient and sustainable travel around Dublin. This investment in the M50 supports economic growth, better connects surrounding communities, and contributes to a comprehensive transportation network for the entire country.

4 - YFG calls for the development of a rail line connecting Letterkenny and Derry to Dublin.

The development of a rail line connecting Letterkenny and Derry to Dublin aims to enhance regional connectivity, reduce travel times, and promote economic growth. By linking these cities to the capital, this new transportation infrastructure encourages investment in previously underserved areas, fosters tourism, and facilitates greater collaboration between regions. The rail line also supports sustainable transportation by providing an alternative to private vehicles, reducing traffic congestion, and lowering carbon emissions.



5 - YFG calls for the development of a rail line connecting all major airports (Dublin, Belfast, Cork and Shannon) on the island to the nearest hub.

The development of a rail line connecting all major airports on the island aims to improve accessibility, streamline travel, and support economic growth. By offering seamless connections between airports and city centres, this rail network promotes sustainable transportation, reduces traffic congestion, and encourages tourism. 6 - YFG calls for the introduction of Glider into areas that are less economically viable for light rail such as Galway, Waterford and Limerick.

The introduction of glider systems (trolley bus) in areas like Galway, Waterford, and Limerick, where light rail may be less economically viable, provides an efficient and sustainable transportation alternative. These high-capacity, rapid transit buses improve connectivity, reduce travel times, and promote public transport usage. By investing in glider systems, these cities can enhance their transportation infrastructure, support economic growth, and contribute to a greener future without incurring the costs of developing light rail networks.

7 - YFG calls for the coordination of electric charging point locations in the border communities.

The coordination of electric charging point locations in border communities aims to facilitate seamless electric vehicle (EV) usage across the island, promoting sustainable transportation and reducing emissions. By strategically placing charging points in these areas, drivers can conveniently recharge their EVs and travel between jurisdictions without range anxiety. This coordinated effort encourages EV adoption, supports local economic growth, and fosters cross-border cooperation in the pursuit of a cleaner, greener future.

8 - YFG calls for the introduction of a subscription-based service on public transport in cities.

The introduction of subscription-based services on public transport in cities aims to simplify fare structures and encourage increased ridership. By offering unlimited access to various modes of transport for a fixed monthly fee, this approach makes commuting more convenient, predictable, and cost-effective. The subscription model supports sustainable transportation habits, reduces traffic congestion and carbon emissions, and enhances the overall quality of urban life by promoting efficient, accessible, and integrated public transport systems.

9 - YFG calls for the introduction of a park-and-ride scheme in all major towns and cities with public transport on the island, service to be carried out with free parking.

The introduction of park-and-ride schemes in all major towns and cities with public transport on the island aims to reduce traffic congestion and promote sustainable commuting. By offering free parking at strategically located facilities, commuters can easily switch from private vehicles to public transport for their daily journeys. This initiative encourages the use of public transport, decreases carbon emissions, and improves overall quality of life by alleviating traffic-related stress and reducing the demand for inner-city parking.



10 -YFG calls for the introduction of a scheme to encourage the expansion of e-bikes.

The scheme would offer financial incentives such as subsidies, tax credits, or grants to encourage individuals, businesses, and organizations to adopt e-bikes for transportation purposes. 11 - YFG calls for the implementation of a comprehensive expansion of night bus services, including the establishment of a late-night bus service between Dublin and Belfast, as well as the expansion of night buses along all busy routes in the island's cities.

This initiative aims to enhance connectivity, cater to diverse travel needs, promote economic growth, and provide a safe and convenient transportation option during off-peak hours, supporting sustainable mobility and improving the quality of life for residents and visitors.

12 - YFG calls for the implementation of a bike share scheme to be introduced in towns with a population of 25,000 or greater.

The implementation of a bike share scheme in towns with a population of 25,000 or greater aims to promote sustainable transportation, reduce traffic congestion, and improve air quality. By providing easily accessible bikes for short-term rentals, this initiative encourages active mobility, supports healthier lifestyles, and fosters a sense of community. Implementing bike share schemes in these towns contributes to greener urban environments and enhances the overall quality of life for residents.

2.2 Reform

1 - YFG calls for the creation of an all-island leap card/ contactless payment on all public transport throughout the island by 2025.

The introduction of an all-island leap card/contactless payment system for public transport streamlines travel across the island, enhancing convenience and accessibility for commuters. This unified payment method simplifies fare payments, encouraging the use of public transport and promoting sustainability. By integrating payment systems across various transport modes and regions, this initiative fosters seamless connectivity, reduces barriers to travel, and supports a greener, more efficient transportation network.

2 - YFG calls for the creation of an all-island transport authority as suggested in the Good Friday agreement strand 2.

The creation of an all-island transport authority, as suggested in the Good Friday Agreement's Strand 2, aims to improve coordination and cooperation between Northern Ireland and the Republic of Ireland. This unified body will oversee the planning, management, and development of



cross-border transport infrastructure and services, facilitating seamless connectivity and fostering economic growth. By working together, both jurisdictions can address shared challenges, promote sustainable transportation solutions, and enhance the quality of life for their citizens.

3 - YFG calls for the government to investigate the introduction of city loops into Cork, Belfast and Dublin.

By introducing circular transit routes that connect key destinations within these cities, city loops promote efficient travel, reduce transfer times, and increase public transport usage. 4 - YFG calls for the government to investigate the feasibility of improving connectivity between Belfast and areas located on the west coast such as Enniskillen, Sligo, Galway and Bundoran.

5 - YFG calls for the government to launch an advertising awareness campaign on government-funded public transport in rural communities.

6 - YFG calls for the government to investigate the development of a hub and spoke transport system in our cities.

By creating central hubs that connect various transport modes with radial routes, this system facilitates efficient transfers and convenient access to key destinations. 7 - YFG calls for the government to conduct a study on e-scooter regulations. Conducting a study on e-scooter regulations is important to ensure the safety of riders, pedestrians, and other road users.

8 - YFG calls for the government to investigate the use of excess capacity in our rail network for freight.

9 - YFG calls for a cross-party agreement on key transportation infrastructure over a 10-year period.

This agreement would ensure that projects are planned and executed with a long-term view, reducing the risk of changes in priorities due to political changes or short-term economic considerations. By establishing a roadmap for transportation infrastructure development over a decade, the government could provide certainty for investors and contractors, encouraging long-term investment and stimulating economic growth. 10 - YFG calls for the government to enforce the hiring of an environmental expert to advise during the feasibility study process.

11 - YFG calls for the establishment of new clean air zones in the centre of major cities throughout the island.

12 - YFG calls for the pedestrianization of high-footfall areas in the city after a community consultation process.
